SPONSORED FOOD SERVICE AND RETAILER SIAL PARIS  
EDUCATIONAL TRIP  
OFFICIAL SELECTION RULES**

Void outside the 50 United States and the District of Columbia, and where prohibited. Do not enter unless you meet all of the eligibility criteria. By participating, you agree to be bound by these Official Rules and the decisions of the Cheese Importers Association of America Imported Cheese Board (ICB), which are binding and final in all matters relating to selection of Food Service/Retailers for the ICB Sponsored Food Service/Retailer SIAL Paris Educational Trip.

**NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASING PRODUCT FROM A MEMBER OF ICB WILL NOT INCREASE YOUR CHANCES OF WINNING.**

Applications for ICB Sponsored Food Service/Retailer SIAL Paris Educational Trip begins at 12:01 a.m. Eastern Daylight Time (“EDT”) on 10/01/2019 and ends at 11:59 p.m. EDT on 7/30/20 (“Application Period”).

**SPONSOR:** Cheese Importers Association of America Imported Cheese Board, 204 E Street, NE, Washington, DC 20002.

**PURPOSE:** ICB is sponsoring an educational trip for fifteen (15) Food Service/Retail cheese buyers to attend the SIAL Paris Food Show October 18-22, 2020 for the purpose of educating food service/retail cheese buyers about the variety, quality, and marketing opportunities of fine cheeses from throughout the world and promoting effective retailing of cheeses.

**HOW TO ENTER:** During the Application Period, visit [www.theciaa.org](http://www.theciaa.org) and follow the instructions provided to submit a completed SIAL Food Service/Retailer Application to receive one (1) application. There is no cost to apply. Applicants are limited to one application. Applications may be submitted by mail to ICB, 204 E Street, NE, Washington, DC 20002 or fax to 202-547-6348. ICB will send an e-mail to each applicant to confirm receipt of their application. All applications must be submitted by 11:59 p.m. EDT on 7/30/20 to be eligible. All applications become the property of Sponsor and will not be returned.

**LIMIT:** One (1) application per person and per email address. Any person filing multiple applications may be disqualified, at the discretion of the ICB. Entries received from any person or email address in excess of the stated limitation will be void. You may only use one email address to apply for the ICB Sponsored Food Service/Retailer SIAL Paris Educational Trip.

**ELIGIBILITY:** The ICB Sponsored Food Service/Retailer SIAL Paris Educational Trip application is open to persons who meet all of the following eligibility criteria:

1. Applicant is a decision maker that is a dairy category manager, cheese buyer, or deli buyer of a food retail business that has 5 or more retail establishments or which purchased at least 250,000 lbs of wholesale specialty cheese between 1/1/19 and 12/30/19.
2. Applicant is a decision maker that is a food buyer or culinary director for a Restaurant Group or Restaurant Chain that has 15 or more locations/restaurants with a minimum cheese purchase of 250,000 lbs between 1/1/19 and 12/30/19.
3. Applicant is a decision maker that is a culinary director, chef, category manager or food buyer for a Hotel Chain or Cruise Line with a minimum cheese purchase of 250,000 lbs between 1/1/19 and 12/30/19.
4. Only one winner per company will be allowed. (Exception for companies with different buying entities)
5. Applicant has current signed permission of his/her employer to fully participate in the trip, if chosen.
6. Applicant is a legal resident of the 50 United States and the District of Columbia; and
7. Applicant is 21 years of age or older.

Employees of Sponsor, and any other organizations affiliated with the sponsorship, fulfillment, administration, trip support, advertisement, or promotion of the ICB Sponsored Food Service/Retailer SIAL Paris Educational Trip and each of their respective parents, agents, affiliates, subsidiaries, and advertising and promotion agencies, and members of their immediate families (regardless of where they reside) or household members, whether or not related, are not eligible to enter or win. "Immediate family members" shall mean spouses, parents, step-parents, children, step-children, siblings, step-siblings, and their respective spouses. "Household members" shall mean people who share the same residence at least three (3) months a year.

**WINNER SELECTION DRAWING:** On or about 8/6/20, Sponsor will conduct a random drawing from among all eligible applicants received to select fifteen (15) potential winners and four (4) alternates. Sponsor may, in its sole discretion, decline to select as potential winners more than one employee of a Food Service/Retailer. In the event that more than one potential winner employed by a particular Food Service/Retailer is drawn, Sponsor, in its sole discretion, may determine which employee of the Food Service/Retailer will be deemed the potential winner. Odds of winning depend upon the number of eligible entries received.

**WINNER NOTIFICATION:** Potential winners will be notified via email, phone and/or mail and will be required to complete and return an Affidavit of Eligibility,

and Release of Liability/Publicity within ten (10) days of date of notification. Also, potential winners will be required to provide such information as may be necessary to verify their eligibility. If such documents are not returned within the specified time period, potential winner notification is returned as undeliverable, Sponsor is unable to contact potential winner or potential winner is not in compliance with these Official Rules, winner status will be forfeited and, at Sponsor's discretion, an alternate winner selected. Sponsor, in its sole discretion, will make final selection of winners.

**ICB SPONSORED FOOD SERVICE/RETAILER SIAL PARIS EDUCATIONAL**

**TRIP:** An educational trip for one (1) to Paris, France, including roundtrip air transportation for one (1) from a major U.S. gateway airport to Paris, France; five (5) nights' accommodations at a hotel determined by Sponsor in its sole discretion (single room, single occupancy); and ground transportation, meals, educational seminar and meetings, luggage fees, gratuities and other incidental expenses, total ARV of educational trip package is \$6,500.

Travel must be made through Sponsor's agent, on a carrier of Sponsor's choice. Certain blackout dates and travel restrictions may apply. Travel is subject to availability. All trip details are at Sponsor's sole discretion. Winner may upgrade or change itinerary with Sponsor's prior approval.

The trip is awarded "as is" with no warranty or guarantee, either express or implied by Sponsor. Winner may not substitute, assign or transfer rights to the trip. Sponsor reserves the right, at its sole discretion, to modify the trip or provide substitution therefore. Winner is responsible for all applicable federal, state and local taxes, if any, as well as any other costs and expenses associated with trip acceptance and use not specified herein as being provided.

**PRIVACY:** Registration at [www.theciaa.org](http://www.theciaa.org) is required to apply for the ICB Sponsored Food Service/Retailer SIAL Paris Educational Trip. When you register, we collect personally identifying information about you, including your name, complete mailing address, and email address. By entering and providing the required registration information, you acknowledge that Sponsor may send you information. Your email address will not be sold or rented to third parties. IF YOU DO NOT WISH TO SHARE YOUR INFORMATION, PLEASE DO NOT ENTER THE ICB SPONSORED FOOD SERVICE/RETAILER SIAL PARIS EDUCATIONAL TRIP SELECTION PROCESS.

**ARBITRATION:** Except where prohibited by law, as a condition of participating in this Selection Process, participant agrees that: (1) any and all disputes, claims, and causes of action arising out of or connected with this Selection Process, or any participation in the SIAL Paris Education Trip, shall be resolved individually, without resort to any form of class action; and exclusively by final and binding arbitration under the rules of the American Arbitration Association and held at a AAA regional office in New York, NY; (2) the Federal Arbitration Act shall govern

the interpretation, enforcement and all proceedings at such arbitration; and (3) judgment upon such arbitration award may be entered in any court having jurisdiction. Under no circumstances will participant be permitted to obtain awards for, and participant hereby waives all rights to claim punitive, incidental or consequential damages including attorney's fees or any other damages, other than for participant's actual out-of-pocket expenses (i.e., costs associated with participating in the ICB Sponsored Food Service/Retailer SIAL Paris Educational Trip Selection Process), and participant further waives all rights to have damages multiplied or increased.

**RELEASES:** By participating in the ICB Sponsored Food Service/Retailer SIAL Paris Educational Trip Selection Process, applicant agrees to release Sponsor, and any other organizations affiliated with the sponsorship, fulfillment, administration, educational trip support, advertisement or promotion of the ICB Sponsored Food Service/Retailer SIAL Paris Educational Trip and each of their respective parents, agents, affiliates, subsidiaries, advertising and promotion agencies, and educational trip sponsors, and each of their respective officers, directors, agents, representatives and employees, as well as each of their respective successors, representatives and assigns (collectively, the "Released Parties") from any and all actions, claims, injury, loss or damage arising in any manner, in whole or in part, directly or indirectly, from participation in the ICB Sponsored Food Service/Retailer SIAL Paris Educational Trip Selection Process and/or acceptance or use of the ICB Sponsored Food Service/Retailer SIAL Paris Educational Trip.

Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking or by any equipment or programming associated with or utilized in the Selection Process. Released Parties are not responsible for injury or damage to participants' or to any other person's computer related to or resulting from participating in this Selection Process or downloading materials from or use of the website. Sponsor reserves the right, in its sole discretion to disqualify any person tampering with the application process, the operation of the

Sponsor further reserves the right, in its sole discretion, to cancel, terminate or modify this Selection Process if the Selection Process is compromised by virus, technical corruption, non-authorized human intervention, or any other causes which, in the sole discretion of the Sponsor, corrupt or affect the administration, security, fairness, proper play or integrity of the Selection Process. Sponsor reserves the right in its sole discretion to disqualify any individual it believes has tampered with the application process. In the event of cancellation or termination, Sponsor reserves the right to select the winner in a random drawing from among all eligible, non-suspect entries received prior to date of cancellation or termination. In the event of a dispute regarding online application, application will be deemed made by the authorized account holder of the e-mail account associated with the application and he/she must comply with these Official Rules. The authorized account holder is the natural person who is assigned the e-mail address by the Internet Service Provider (ISP), on-line service provider, or other organization responsible for assigning email addresses.
